

Seminars:

"Learning by Doing" (part 1)

Roughly outlined the training covers:

- A view of that we want to demand or what we demand to our dog,
- Recognition and analysis of the characteristics of our dog,
- Structure of a dog, producing the right and true motivation,
- How to teach dogs (Kinds of learning),
- Setting signals as trigger mechanism for certain behavior,
- Attention wake and strengthen, process of training,
- Absorption, Adherence, Safeguarding of the training we do.

A more detailed theoretical part with a special portion over reactive and active learning behavior and their practical application in the training for practice, particularly obedience, can be offered likewise.

Also the discussion over dogs with a negative experience in the training or the stimulation-reaction-learning are possible. In practice the theoretical beginnings are used. If desired, problem treatments and their solution can be the center of attention with advanced dogs. According to the principle "Learning by Doing" I will work in each department with dog and handler.

I think that it's important not to point out only the possibilities. The participants must get the opportunity to learn the process in order to use it practically with their dog independently. Also the training of helpers for the Abtlg. C could be also included.

"Learning by Doing" (part 2)

this is a seminar for handlers who had visit the first seminar or practice this kind of training. The communication and training will be more intensive.

"Only protection work"

A special seminar for helpers and/or competition helpers. I always see problems with grips, regarding an obedience in the whole protection work. Here I will explain how a structured "building up" at the dog will work. Both – technical processes as well as emotional stakes are explained.

"Tracking"

At this seminar I will show how to build up a young dog. But also how to solve problems at older dogs will be shown and explained.

Other Seminars I had done:

In the years 2002 and 2003 I was active with the Westfaelisches Studieninstitut Münster as a guest lecturer. Here were offered two seminars by me with the following topics:

1. Evaluation of dangerous dogs by the law.

It was specially for people of the local order and veterinarian authorities. They were instructed, which correctly estimate different characters of dogs due to their body language, and convert in measures to the laws.

2. Practical handling of dangerous dogs.

Here I instructed coworker by environmental or offices for order, social services or refuse economy enterprises of the municipalities the behaviors of dangerous dogs. How to estimate behaviors and how to minimize so the self-endangerment as far as possible.

3. Animals in the Law.

In the year 2002 by me and others one well 60 sides comprehensive seminar work was written with the topic of "animals in the law". It was concerned with the question whether dog training is located in the context of the IPO-sport meaningfully and in conformity with the following a regional law defaults. Here it could be represented descriptive that a kind and fair education and training of our dogs only can be helpful for the well-being of our social structure.
